What are the issues?

Look at what has occurred and it was not us that did it.

AllThis is about political persecution. Are you the next target??

This was done to us by deliberate criminal acts of government and their coerced or willing agents. These crimes are still on going.

Many who hear about AllThis think that if they speak out about it, then the same will happen to them. So many who hear about AllThis are silent.

But those who remain silent will find that it will happen to them anyway, only worse.

When a government agency routinely creates fraudulent assessments, counterfeit third party demands, uses extortion, tampers with evidence, lies in court, abuses the justice system, creates false liens to seize assets, then they are conducting themselves as a criminal organization and it is appropriate for citizens to despise such activities and have this stopped and corrected.

OUR CASE SPANS BORDERS IN THE LEGAL FIELDS OF:

1. INTELLECTUAL PROPERTY
2. HUMAN RIGHTS
3. ENVIRONMENTAL LAW.

This is not about incidences of government funded agents making accidental medical malpractice errors or merely about clerical errors in records but instead it is about deliberate acts of malpractice, the altering of official documents with the intention to do as much harm as possible, the intentional overspraying and poisoning and killing of our farm animals, theft of our property, the damage to our reputation..... The list goes on. Others in our community have been targeted. Are you next?

This first example is just the tip of an iceberg. It shows that the legal justice system is routinely abused and the supreme court decisions ignored as if they never happened. Even minor injustices should not be tolerated. Actions by our government should be the gold standard of behaviour but collectively and fundamentally, the following was a hint that the government of Canada did not and would not respect the rule of law or the justice system.

In 1993, the federal government, based on a Supreme Court of Canada ruling, offered an incentive (bribe) my company (Subsea Cities Inc.) to hire my spouse as an employee in order to be eligible for unemployment insurance benefits, but after they obtained what they wanted (statistics showing job creation) they ignored my written contract with my employee and made up their own version which they then used to claim that my spouse was not eligible for benefits, despite the Supreme Court of Canada ruling. The federal government then demanded their incentive (bribe) back. My company suffered damages as a result of this counterfeit employee contract that they had fabricated, so I refused to refund the incentive. This ultimately resulted in a lawsuit against my company and me, which ultimately resulted in a mistrial due to tampering with evidence that we had submitted to the Supreme Court of Canada. The evidence itself of evidence tampering was later "lost" by a legal firm while returning it by bonded courier and appeals to the Nova Scotia Barristers Society about this, were deemed not relevant as tampering with evidence was so common it was considered as acceptable normal legal practice.

This was just the beginning of "attacks" against my wife and ultimately me/us and our community. A motive, as far as I can determine, was in response to my wife "discovering" currency manipulation that affected elections and reporting and corresponding on this and other topics with a CBC journalist, Bill Cameron, now deceased, along with many others (also now deceased) who at some time, had some involvement with us.

Here is a list of some of the issues:

There was an abortion without informed consent which resulted in the murder of our unborn child and the sterilization of my wife.

There was an office rape of my wife by a prominent Nova Scotia government funded physician, followed by the altering of medical records and the refusal of the Medical Complaints Board to investigate.

Our farm property was poisoned by over spraying of herbicides and pesticides by government sanctioned aircraft, which resulted in the deaths of many of our farm animals, damage to our watershed and water supply and corrosion of our soil and farm infrastructure. This continued with harassment by helicopters and small aircraft, ultimately resulting in the death of our horse after a "buzzing" by a helicopter. Complaints to the RCMP were replied with by requests for us (not them) to identify the aircraft, however, the small aircraft spraying chemicals on us had no

identification numbers as they appeared to have been taped over, and the helicopters in many cases, were ones used by the RCMP itself.

Such horrific traumas to my wife (and me) eventually inspired her to write a book called "A Woman's Work: Tweed and Sequins" which was self-published by a Book Publishing company she owned.

This book, although legally purchased by the Widener Library at Harvard, was otherwise plagiarized, widely secretly distributed, used without any acknowledgment or compensation, and then suppressed. For example, copies were removed from the NS Library system and all reference to it purged from the reference index as if to create the impression that it had never existed.

This was just the beginning of the political persecution by the the Canadian federal and Nova Scotia provincial governments and their agents, many of which were coerced threaten and misinformed in order to force them to carry out crimes on behalf of the government and for others, who know about this, to remain silent.

It appears that for decades Canadian governments used and continue to use criminal actions to deliberately harm people, although it is finally become more public. For example, here is a link to a WFive TV program that we were told about:

Some that we have talked to have indicated that the Canada Revenue Agency (CRA) is unpopular (even hated). This need not be the case if everyone were treated fairly and honestly. However, if a government agency routinely creates fraudulent assessments, counterfeit third party demands, uses extortion, tampers with evidence, lies in court, abuses the justice system, creates false liens to seize assets, then they are conducting themselves as a criminal organization and it is appropriate for citizens to despise such activities and have this stopped and corrected.

Such political persecution has been and continues to be directed against me and my wife. Here are some more examples.

In 2004 the Nova Scotia government brought a charge against my wife, in an attempt

to circumvent and retry the previous failed mistrial. Despite registering just cause for not participating in a "new" trial and prior to the eventual court trial, submitted a notarized statement and demand for compensation, my wife was arrested and jailed and dragged into court anyway. The province then tried to abandon their involvement and let the federal government adopt their prosecution but due to lies, tampering with evidence and abuse of the justice system, **she appealed to the Supreme Court of Nova Scotia, and WON**. She/we are now owed the compensation specified in the court documents.

However, instead of honourably paying us what we are owed, they purged records of the court case from the public files and now claim no knowledge that the 2 years and 10 very real court dates and verdict ever occurred. Instead they now consider us "Non Persons".

In addition, they (through the CRA) then proceeded to fabricate false fraudulent income tax assessments, which they then used to create counterfeit third party demands which were then used to coerce bank officials to seize our assets, freeze our bank accounts and garnish 100% of any employee income, should we attempt to earn income. They also used these counterfeit documents to place false liens on our property in an attempt to collect income tax on the purported income they claim we earned as stated in their fraudulent tax assessment.

Besides being criminal the harm has been deliberate.

These criminal activities by the Canadian governments was deliberate and intended to create other somewhat indirect, adverse impacts on us. Here are some examples:

We are prevented from remortgaging our property at a reduced interest rate and therefore have to pay a higher rate than what could be offered, thereby enriching the bank in return for stealing our cash assets. We have been forced to spend all of our savings, including a large inheritance, to pay our living expenses and to make monthly payment on debts.

When all our cash reserves were used up, we were then forced to sell real assets in an attempt to maintain credit card, utility and mortgage payments.

Our ability to earn income to pay legitimate debts is hampered because our bank accounts are frozen and any funds put into the account to pay such debts will be seized.

We are now not permitted to use personal credit cards because the seizing of assets, the freezing of our bank accounts and the garnishment of income has prevented us from even paying the minimum monthly payments that become due. These accounts are now in default even though the funds to pay for them and owed to us is being held by the Canadian federal government. Our electric power service which is used for heat, light and water is threatened to be cut off even though this will cause damage to our property and the deaths of our remaining farm animals unless there is intervention. Even emergency phone service is being threatened with disconnection.

We are not permitted to borrow money from lending institutions because we have no earned income to report since any employee income is 100% garnished.

We are not permitted access to legal aid for assistance in correcting the fraudulent income tax assessments because legal aid uses the fraudulent income tax assessment itself to justify its assertion that we do not qualify for assistance because our monthly income would be greater than the maximum in their eligibility table if the assessments were valid.

We are not permitted access to other lawyers within the province because the Nova Scotia Barristers Society has regulations governing "conflict of interest" and since lawyers in Nova Scotia are licensed to practice for "the crown" they are not obligated to assist us to correct injustices done in the name of "the crown".

We can not utilize lawyers from outside of Nova Scotia because they are not licensed to practice within Nova Scotia.

We are not permitted to make municipal tax payments and this could result in a tax sale of our property.

We are not permitted to obtain house insurance which was canceled after we reported finding Indian artifacts that proved that the The Passamaquoddy Nation occupied territory now in the USA and Canada prior to the Mi'kmaq.

We are not permitted to maintain car insurance which was canceled despite being overpaid.

We are not permitted to hire contractors to maintain our farm and house property.

We are not permitted to travel together.

We are not permitted to have a family doctor.

We are not permitted to have access to high speed internet.

We are not permitted to have cellular phone service.

Our communications are routinely interfered with so if you have been able to access this document, then it might be a sign that perhaps, a resolution to these issues is pending.

That would be good news because to date, there has been no acknowledgment of letters and invoices sent to the Canada Revenue Agency, nor has there been any notification of the intention of the Canada Revenue Agency [d.b.a. the governments of Canada; -the "Queen"] to resolve the many outstanding -and Critical- Issues of Our Case.

Nothing honourable has ever been done to resolve the extant, Critical, Legal Issues between us; instead, we have recently received new erroneous demands from the CRA. Canadian citizens and others impacted by these criminal acts of the Canadian governments, should be aware that there are mounting damages to us, specifically due to the lengthy delay in payment of this Debt to us by the Federal and Nova Scotia Provincial governments. This is costing us Canadian taxpayers an additional \$33,338.01 per month, just in interest alone, on the balance due us as a result of their failed lawsuit, each month that our invoice remains unpaid. This does not include payment for the numerous instances of harm, malpractice and damages just enumerated.

Never the less, we still seek a just resolution to these issues.
